THE TOTAL NUMBER OF BED NIGHTS WAS 2,968 AND THERE WERE HOMELESS FAMILIES SHELTERED FROM JANUARY 1 - DECEMBER 31ST WITH NO VACANT DAYS. THE AVERAGE STAY PER FAMILY WAS 56 DAYS.

THIS WAS THE FIRST YEAR WITH 3 FULL-TIME EMPLOYEES. BRIDGET PITMAN WAS HIRED AS THE VOLUNTEER DIRECTOR AFTER SERVING AS A VISTA VOLUNTEER FOR THE PREVIOUS YEAR. VOLUNTEER TRAINING AND COORDINATION WAS GREATLY PROFESSIONALIZED, AND AN ADDITIONAL 253 VOLUNTEERS WERE TRAINED, FOR A TOTAL OF 1292 VOLUNTEERS. THIS IS A PHENOMENAL ACHIEVEMENT FOR AN ORGANIZATION IN ITS FIFTH YEAR OF OPERATION!
