THESE PROGRAMS INCLUDE EVICTION PREVENTION, HELP US MOVE IN, AND DIVERSION. NOW OUR PROGRAMS COVER PREVENTION, SHELTER, AND STABILIZATION. THIS YEAR WE SERVED 7 FAMILIES WITH PREVENTION PROGRAMS, 14 FAMILIES IN SHELTER, AND 10 FAMILIES IN STABILIZATION PROGRAMS.

THE ORGANIZATION WAS IMPACTED BY THE COVID 19 PANDEMIC DURING 2020. IN ORDER TO COUNTERACT THOSE IMPACT, FAMILY PROMISE OF GALLATIN VALLEY APPLIED FOR AND RECEIVED A PPP LOAN AS WELL AS A \$205,000 COVID GRANT.
